## MIAMI SOUTHRIDGE SENIOR HIGH SCHOOL CHEERLEADING CONSTITUTION

A Southridge Cheerleader is a true representative of the school and must always set the highest standards of character and conduct. Everything a cheerleader does reflects on the squad, and for that reason, cheerleaders must always be careful to act in a courteous manner, conscious of the fact that they are constantly on display.

A cheerleader must assume their many responsibilities with ENTHUSIASM. Their spirit is never daunted, and their smile never saddened. The squad as a whole is more important than the individual's desires.

#### **RESPONSIBILITIES**

- A. A cheerleader must always promote school spirit.
- B. Cheerleaders must always set an excellent example.
- C. Cheerleaders must be responsible for all activities undertaken by the squad.
- D. Cheerleaders must be enthusiastic about all duties and must participate without having to be reminded.
- E. Cheerleaders must participate in all major spirit activities promoted by the school.
- F. Each cheerleader must attend the summer clinic designated by the sponsor.
- G. Cheerleaders must attend a meeting EVERY MONDAY from 2:30- 3:00 pm.
- H. Cheerleaders must abide by the constitution.

#### **GRADES**

- A. Cheerleaders must maintain a cumulative 2.0 GPA.
- B. Cheerleaders must maintain a "C" or higher average in Scholarship in every class.
- C. Cheerleaders must not have a conduct grade lower than a "C."
- D. Cheerleaders must not have lower than a "2" in effort in each class.
- E. Grades will be checked every 4 ½ weeks.
- F. A 4 ½ week probation will result when a cheerleader obtains one scholastic, conduct or effort grade below required standard.
- G. A 9-week probation will result when a cheerleader obtains **more than one** grade (scholastic, conduct, effort) below required standard.

#### **CONDUCT**

#### A Cheerleader:

- A. Shall not display disorderly conduct while in school or at any school function.
- B. Shall not display excessive personal contact with others (while in or out of uniform) during school hours or while representing the school at functions.
- C. May not smoke, vape, drink alcohol, or use any illegal drugs.
- D. Must obey all school rules.
- E. Must always display the highest standard of conduct.
- F. Shall leave all personal problems for outside school functions.
- G. Is responsible for all his/her actions in and out of school.
- H. Must refrain from posting to social media any material that reflects poorly on the reputation of the individual cheerleader and/or the squad.
- I. Any reports of misconduct from any faculty member will result in a **4 1/2 week benching** and **1 demerit**.

#### **SCHOOL ATTENDANCE**

- A. Cheerleaders may NOT accumulate more than 10 absences (excused or unexcused) for the school year.
- B. Cheerleaders may NOT accumulate more than 20 tardies (excused or unexcused) for the school year.

#### **APPEARANCE**

#### A Cheerleader:

- A. Shall not wear excessive makeup or extreme hair styles while in uniform. (This includes unnatural hair colors).
- B. Must dress according to the school dress code.

#### **PRACTICES**

- **A. TIMES:** (Approximate and can vary)
  - 1. Football- 1.5 hours, 4 days a week.
  - 2. Basketball & Wrestling- 1.5 hours, 2 times a week.
  - 3. Competition- If attending a competition, practices will be scheduled as needed).
- **B. ATTENDANCE:** (A cheerleader must be present at all practices)
  - 1. If absent from school, do not attend practice.
  - 2. Excused Absence =  $\frac{1}{2}$  cut
    - a. Death in family, illness, other extenuating circumstances.
    - b. Must have appropriate documentation (doctor note, etc.).
    - c. A written excuse must be turned in the day you return.
  - 3. Unexcused Absence = 1 cut.
  - 4. Tardy to practice results in ½ cut.

#### C. UNIFORM

- 1. Practice uniform assigned by the sponsor or captain.
- 2. Practice Shirt (purchased through sponsor).
- 3. Black Shorts
- 4. White socks.
- 5. White tennis shoes.
- 6. Only small stud earring permitted.
- 7. Out of uniform to practice results in ½ cut.

#### **GAMES**

#### A. FOOTBALL

- 1. Southridge Cheerleaders will cheer at **ALL** regular season games and play-off games.
- 2. Missing a game = 1 demerit (excused or unexcused).
- 3. Tardy to a game = 1 **cut**
- 4. Out of uniform = benching for that game and 1 cut.

#### B. BASKETBALL

- 1. Southridge Cheerleaders will cheer at **ALL HOME** games, special away games, and **ALL** playoff games.
- 2. The squad will be split into multiple squads during basketball season.
- 3. Missing a game = 1 demerit (excused or unexcused).
  - a. Cheerleaders needing to miss a basketball game may find a substitute from the other squad.
  - b. Must submit a written notice to their squad captain and the sponsor 24 hours in advance.
  - c. The notice must include the substitute cheerleader's name and signature.
- 4. Tardy to a game = 1 cut.
- 5. Out of uniform = benching for that game and 1 cut.

#### **PERFORMANCES**

- A. This includes pep rallies, competitions, and any other event outside of regular games and practices.
- B. Missing more than one practice during the preparation period for a performance will result in removal from that performance.
- C. If a cheerleader is removed from a performance, they are still required to attend all scheduled practices.
- D. Missing a performance—for any reason, including removal due to missed practices—will result in one demerit.

#### **UNIFORMS**

#### ALL UNIFORMS ISSUED TO EACH CHEERLEADER ARE THE PROPERTY OF THE SCHOOL!

#### A. Hall Uniform

- 1. Hair must be pulled back away from the face. No hair ornaments unless distributed by sponsor.
- 2. Only clear nail polish.
- 3. Only small stud earrings and class rings are permitted.
- 4. Out of Hall Uniform = 1 cut

#### B. Game & Pep Rally Uniform

- 1. Hair- pulled back in a single ponytail. No hair ornaments unless distributed by sponsor.
- 2. Only clear nail polish
- 3. Only small stud earrings and class rings permitted.
- 4. Out of Game Uniform = benching and **1cut**

#### C. MISCELLANEOUS INFORMATION

- 1. A cheerleader may not wear uniform to any other function other than those specified by the sponsor.
- 2. Must change to street clothes after a game.
- 3. May not wear uniform shopping, to dinner, or in public unless with the squad.

#### **DISCIPLINE**

#### A. CUTS AND DEMERITS

- 1. Cuts and demerits are used to monitor a cheerleaders conduct.
- 2. **CUTS** are given for smaller infractions; **DEMERITS** are given for more serious infractions.
- 3. Cuts are cumulative: Every **2 cuts** will automatically convert to **1 demerit**.
- 4. **6 Demerits** results in expulsion from the squad.

#### **B. ATTENDANCE INFRACTIONS**

- 1. Tardy to practice =  $\frac{1}{2}$  cut.
- 2. Tardy to game = 1 cut
- 3. Excused absence for practice =  $\frac{1}{2}$  cut (must have note).
- 4. Unexcused absence for practice = 1 cut.
- 5. Absence from game (excused or unexcused) = 1 demerit.

#### C. INFRACTIONS RESULTING IN CUTS

- 1. Out of uniform at practice (½ cut).
- 2. Out of Hall Uniform.
- 3. Out of uniform at game (benched and 1 cut).
- 4. Chewing gum at practice or game.
- 5. Use of your cellular phone at practice or game.
- 6. Behavior problems at practice.
- 7. Behavior problems at game (benched and 1 cut).
- 8. Talking back to any officer or sponsor.
- 9. Failure to practice properly.
- 10. Failure to follow instructions given by the sponsor, or officer.
- 11. Not turning money in on time.
- 12. Not participating in spirit functions.
- 13. Missing deadlines.
- 14. Missing meetings.
- 15. Other behaviors may result in disciplinary actions as deemed fit by the cheer sponsor(s).

#### D. INFRACTIONS RESULTING IN DEMERITS

- 1. Breaking a school rule.
- 2. Irregular attendance to classes.
- 3. Disorderly conduct.
- 4. Disrespecting a staff member
- 5. Other behaviors may result in disciplinary actions as deemed fit by the cheer sponsor(s).

#### E. BENCHING

- 1. 1 Demerit =  $\frac{1}{2}$  Game Benching
- 2. Sponsor will have ultimate authority to bench a cheerleader.
- 3. A cheerleader is to be present at all athletic contests at the specified time and place.
- 4. A cheerleader is not excused from being present while benched.
- 5. Any irregularity in cheerleaders' attendance to classes will result in automatic benching for 4 ½ weeks and 1 demerit.

#### F. PROBATION

- 1. Will occur due to inadequate grades.
- 2. Unable to cheer during probation period.
- 3. Unable to wear uniform, attend practices, games, spirit functions, etc. (MUST ATTEND ALL REQUIRED MEETINGS AND PARTICIPATE IN ALL FUND-RAISING ACTIVITIES.)
- 4. Probation is only valid once a year. More than once results in expulsion.
- 5. Breaking of probation results in expulsion.
- 6. Cheerleaders will be notified of probation in writing.

#### G. EXPULSION

- 1. Six (6) demerits = expulsion.
- 2. Drinking alcoholic beverages while in practice, game, or hall uniform or while representing the school.
- 3. Smoking or vaping while in uniform.
- 4. Using illegal drugs.
- 5. Any incident that is harmful to the individual's or squad's reputation, only after thorough investigation.
- 6. Lending out any uniforms or equipment without permission from the sponsor (uniform, shakers, bag, jersey, etc.)
- 7. Once a cheerleader is expelled or voluntarily quits, the individual may not return or try out for the following year.

#### H. PRIORITIZE CHEERLEADING

- 1. While participation in other sports or clubs is allowed, cheerleading must take priority over all other extracurricular activities.
- 2. Missing scheduled cheerleading events (such as meetings, practices, games, etc.) due to involvement in other activities will result in appropriate cuts and demerits.

#### I. WORKING OFF DEMERITS (OPTIONAL)

To work off one demerit, you must complete each of the following to the satisfaction of the sponsor:

- 1. Complete four (4) hours of school service as assigned by the student activities director.
- 2. Teach the varsity and the J.V. squad one complete original cheer (words and motions).
- 3. Teach the varsity and the J.V. squad two (2) complete, original chants.
- 4. You must arrange with the sponsor all service(s) and times necessary for teaching the cheers/chants two (2) weeks prior to doing them.
- 5. A form must be signed by the sponsor upon completion of each of the above.
- 6. You may only work off one (1) demerit per year.

BEFORE ANY EXPULSION, THE SPONSOR WILL CONSIDER IT CAREFULLY

#### **OFFICERS**

#### A. VARSITY CAPTAIN

- 1. Must be a senior and second year varsity member.
- 2. Must not carry over more than 3 demerits from previous year.
- 3. Will be voted on by the squad and approved by the sponsor.
- 4. In charge and responsible for the conduct of the squad at all times.
- 5. May recommend disciplinary actions to the sponsor.
- 6. Must organize and plan all activities of the squad with the sponsor.
- 7. Must always keep pace with all the other duties.

#### B. VARSITY CO-CAPTAIN

- 1. Must be a junior or senior and second year varsity member.
- 2. Must not carry over more than 3 demerits from previous year.
- 3. Will be voted on by the squad and approved by the sponsor.
- 4. Must assist captain in fulfilling all activities and duties.
- 5. Will become captain of the divided groups during sports outside of football season.
- 6. Will be in charge and responsible for the squad in the absence of the captain.

#### C. SECRETARY

- 1. Must be a senior or a junior.
- 2. Appointed by the sponsor.
- 3. Calls role.
- 4. Keeps track of cuts, absences, demerits, notes for absences, and service points.
- 5. May become captain of the divided groups during sports outside of football season.
- 6. Will be in charge and responsible for the squad in the absence of the captain or co-captain.

#### D. SERGEANT AT ARMS

- 1. Appointed by the sponsor.
- 2. Assists the other officers as needed.
- 3. Will be in charge and responsible for the squad in the absence of the other officers.

#### E. JUNIOR VARSITY CAPTAIN

- 1. Voted on by the squad and approved by the sponsor.
- 2. Is responsible for the squad at all times.
- 3. May recommend disciplinary steps to the sponsor.
- 4. Must organize and plan all activities of the squad with the sponsor.

#### F. JUNIOR VARSITY CO-CAPTAIN

- 1. Voted on by the squad and approved by the sponsor.
- 2. Will be in charge and responsible for the squad in the absence of the captain.
- 3. Will become captain of the divided groups during sports outside football season.
- 4. Must assist the captain at all times.

#### **FUND RAISING**

- A. Each cheerleader must raise the required money for all financial needs of the squad.
- B. All fundraising will be determined by the sponsor, the activities director.
- C. The approximate amount will be given at the beginning of the year.

#### SERVICE POINTS

- A. 100 service points must be obtained to receive a letter.
- B. Service points will be given for:
  - 1. Sales above and beyond the required amount.
  - 2. Cheering extra for sports other than football.
  - 3. Any other service over and beyond the call of duty
  - 4. The sponsor and secretary will list the activities and service points received.

#### **CHEERLEADING PARENTS**

- A. Parents are required to provide snacks/drinks at least ONE time during Football Season.
- B. Parents may not be within 100 feet of cheerleading squad during practice and/or games.
- C. Parents are not allowed to speak to cheerleaders during practices and/or games.
- D. Communication with parents will be done via the cheerleaders; the cheerleading sponsors are not responsible for conveying information to the parents, that is the job of the individual cheerleader.
- E. Parents may make an appointment to speak with the cheerleading sponsors. Please call 305-238-6110 and leave a message. The sponsor will return your phone call in a timely manner. You may also email the sponsor to request an appointment.
- F. Conversations about issues WILL NOT take place during events.

#### CHEERLEADER TRYOUTS

- A. Each candidate will be informed of and must meet the requirement of the cheerleader constitution.
- B. Varsity- only sophomores, junior and seniors are eligible.
- C. Junior Varsity- only freshmen are eligible.
- D. The number of cheerleaders on the squad will be mutually agreed upon by the cheerleader sponsor, the activities director, and the principal.
- E. All cheerleaders must sign the contract distributed at tryouts which binds them through the entire school year.

#### **REVIEW OF CONSTITUTION**

A. The cheerleader constitution will be reviewed each year with the new squad to remind all cheerleaders of their responsibilities.
